Dear Food Vendors:

We are pleased to announce the date of “**Sayreville Day 2014**”. It will be held on Sunday, September 14, 2014 at Kennedy Park on Washington Road in Sayreville. The rain date will be Sunday, September 21, 2014.

The event will open to the public at 10:00 a.m. and will promptly end at 4:00 p.m. **All participants must arrive between 7:00 a.m. and 8:00 a.m. to give yourself ample time to set up. You may arrive as early as 6:00 a.m. You will not be allowed into the park with your car after 8:00 a.m.** As you know from last year, you will have to park either in the high school parking lot, on Ernston Road or in Shop-Rite. We will not allow parking in the park.

**Food Merchants Fee is \$300.00.**

**Due to a new policy in the Borough, there will be a mandatory meeting for all food vendors to attend in the summer. Date to be determined shortly. At this meeting, you will receive the paper work you need to obtain any permits you need for the day. There is no need to submit a check with your application. Checks will be accepted at the meeting. Once we receive your application, we will contact you about the meeting. All fees for permits will be included in your \$300 check.**

**If you would like to participate in the Classic Car Show which will be held the day before Sayreville Day, that will be an additional \$100. You will be able to leave your equipment in the park overnight in the food court since we will have 24-hour police presence in the park. Please contact Jerry Ust at the Recreation Dept. at 732-390-2918.**

If you would like to participate in Sayreville Day 2014, we need to know as soon as possible. **Please complete the attached form and return it to my attention at the above address. Be sure that you write exactly what food you will be selling in the "Intentions" part of the application and also make sure you sign the form. With the exception of drinks, we will duplicate foods.**
