Mayor asked Fire Chief Waranowicz to give a detail of the events regarding the DeSarno fire early Monday morning.

Fire Chief Waranowicz gave a detailed description on what they rolled upon that early morning at 451 Main Street. Fire, chaos on the ground, on the roof, inside the building. He said that a neighbor was smart enough and grabbed a ladder to reach the 2nd story roof and as he pulled up he helped him rescue the people from the building along with the police department. He further detailed what happened when his trucks arrived and pumped water onto and into the home. He described it as one of the fastest moving fires he has ever seen to the point where he had to pull his men from the building and attack it from the outside. EMS transported all the patients to the hospital or air medic to the hospital. He thanked all of his men for all they did that early morning. The courage they showed and to the First Aid Squad in helping and assisting these victims.

Kevin Ott said that they too also responded quickly to that job and it wasn't until after the fact they find out who the family was. He said that Morgan First Aid Squad was also on scene as well as two Paramedic Units and North Star Medivac Units. Everyone did an awesome job and prayers are with the family.

Mayor gave a huge thank you to the first responders of Sayreville as they are all volunteer and are responsible for the upkeep of the certifications, equipment, buildings etc. all on their time. They did a magnificent job and thanked them for the professionalism and that they saved a lot of lives that early morning.

Mayor said that the family that was struck is the DeSarno family. Who are very involved in Sayreville. Scouting, band parents, local attorney, past councilman, etc. He announced various fundraisers for this family and how to donate.

CASH MANAGEMENT PLAN Borough of Sayreville JANUARY 2015

I. Purpose

To adopt a policy plan and procedures establishing a formal Cash Management Plan pursuant to N.J.S.A. 40A:5-14.

II. Authority

The Chief Financial Officer is designated as the custodian of all funds and the investment officer of the Borough of Sayreville, and is responsible for investment decisions and activities. All disbursements made by check will be signed by individuals holding the following positions:

- X Mayor
- X Borough Clerk
- X Treasurer / Chief Financial Officer (CFO)

Exceptions to the above are the Net Payroll and Payroll Agency Accounts which are signed by the Treasurer / CFO only. The Treasurer / CFO is authorized to execute wire transfers for purposes of placing investments of idle funds or payment of interest and principal of the Borough's debt.

Disbursements made on the following departmental revenue collection bank accounts will be as follows:

Borough Clerks Office - Borough Clerk

Recreation Department - Director of Recreation

Treasurer/CFO

Office on Aging - Supervisor of Senior Citizen Activities

Treasurer / CFO

Police Department - Chief of Police Municipal Court - Presiding Judge

III. Statement of Policy

It is the policy of the Borough of Sayreville that all cash, checks or any other form of payment received by all officials and employees of the Borough of Sayreville shall be handled, deposited, invested, and accounted for only as provided for in this plan. No deviation from the policies and procedures in the plan is permitted without prior written approval of the Chief Financial Officer.

It is also the policy of the Borough of Sayreville to attempt to earn the maximum rate of return or interest, on all funds, at all times, with the exception of Petty Cash or any other account so precluded by law. Investments shall be made based on statutory constraints. The applicable interest rates shall be the maximum available taking into account safety, liquidity and yield.

IV. Cash Management Procedures

In order to achieve these objectives, departments shall perform the following procedures:

A. <u>Department Procedures</u>

Most departments collect or receive money for various reasons such as permit fees, registration fees, fines, and tax receipts. Each department that collects money is responsible for preparing deposit slips where necessary and transmittal sheets detailing account coding for posting by the Finance Department or the Collection of Taxes. All monies are to be turned over to the Tax Collector or Treasurer for deposit within 48 hours of receipt as per N.J.S.A. 40A:5-15 unless a department head maintains a bank account approved by the Chief Financial Officer for purposes of making daily deposits. Should the department head maintain a bank account, all monies collected by the department must be deposited within 48 hours of receipt as per N.J.S.A. 40A: 5-15. If money or checks must be left over-night, they must be left in a locked, safe and secure location.

Whenever money is received on behalf of the borough, a receipt must be prepared and given to the person rendering the payment. A duplicate of this receipt must be kept. All payments and receipts must be recorded. Each department will be responsible for keeping the duplicate cash receipts in their own offices. The auditor or Chief Financial Officer may request the copy as part of any annual or internal audit.

B. Financial Procedures

Each of the various accounts for which there is a separate bank statement shall be reconciled on a timely basis.

All monies will be counted at the time they are delivered to the tax collector or finance department. Deposits will only be made to banks appearing on the list of depositories approved as part of the Cash Management Plan.

1. Daily Cash Balance Report

This report is compiled by adding each days' receipts as they are deposited or wired into each bank account to the balance of the previous day. Any disbursements by check or wire are subtracted to ascertain the amount of daily idle cash available for investment.

2. <u>Analyzing Cash Flow</u>

By using past history of receipts and disbursements, trends for tax collection and

receipts of other miscellaneous revenues can be established. Payment schedules received from other sources can determine when grants and state aid will be received, as well as when items such as debt, county taxes and school taxes must be paid. Payroll dates and regular council meeting schedules help fix payment dates for payroll and the bill lists. The fiscal year budget also serves as an important tool in determining the timing of receipts and disbursements over the course of the year. All the aforementioned data can be utilized as a means to determine the duration that the available idle cash can be invested.

3. Investment of Borough Funds

All sources of investment are authorized by the Mayor and Council as part of this Cash Management Plan. All banks must receive a Certification of Governmental Unit Deposit Protection Act (GUDPA). The Chief Financial Officer must receive bi-annual certification from the banks. The various vehicles of investment are as follows:

- X Bonds or other obligations of the United States guaranteed by the United States government.
- X Government money market mutual funds.
- X Any obligation that a federal agency or a federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of purchase, provided that such obligation bears a rate of interest not dependent on any index or other external factor.
- X Bonds or other obligations of the Local Unit or bonds or other obligations of school districts of which the Local Unit is a part or within which the school district is located.
- X Bonds or other obligations, having a maturity date not more than 397 days from the date of purchase, approved by the Division of Investment of the Department of the Treasury for investment by Local Units.
- X Local government investment pools.
- X Deposits with the State of New Jersey Cash Management Fund.
- X Certificates of Deposit
- X Overnight Sweep Accounts
- X Bank Money Market Accounts

The investments should be diversified among types and institutions to guard against a sudden default by an institution that may cause a delay in obtaining the invested funds. The maximum amount of funds to be invested in any one type of investment is \$15,000,000.00.

When the amount of the investment has been determined, the approved depositories are called to obtain bids for the most competitive interest rate based upon the duration and the diversification criteria. All investments are flexible to the date required by the finance office to coincide with projected disbursements, rather than to some fixed date (ie. 30 days or 90 days). This flexibility is important, as it allows for maximization of interest realized. Since the cash flow analysis determines when disbursements will be made for all large items (ie. debt service, payroll, bill lists, county taxes, etc.), investments can be timed to mature on the day when payment must be made. This also avoids any chance of not having funds available to meet a payment, which could occur with a more rigid duration of investment.

V. <u>Assuring Compliance</u>

The Cash Management Plan of the Borough of Sayreville shall be subject to the Annual Audit conducted pursuant to N.J.S.A. 40A:5-4.

The official charged with the custody of the monies of the Borough shall deposit them as designated by the Cash Management Plan and shall thereafter be relieved of any liability or loss of such monies due to the insolvency or closing of any depository designated in the Cash Management Plan pursuant to N.J.S.A. 40A:5-14(3)f

WHEREAS, pursuant to N 40A:60-3, "... the president of the council shall perform all duties of the mayor during any period in which the mayor is absent from the borough for three days or more or is unable to perform the duties of his office..."; and

WHEREAS, pursuant to N.J.S. 37:1-13, "...any mayor or deputy mayor, when authorized by the mayor or chairman of any township committee or village president of this State... are hereby authorized to solemnize marriages between such persons as may lawfully enter into the matrimonial relation..."; and

WHEREAS, when these statutes are read together, it is not entirely clear whether the Governor and State Legislature of the State of New Jersey intended that a Mayor of a Borough form of government be specifically required to authorize the President of a Borough Council to be empowered to solemnize marriages in each instance or at such times as the Mayor is legally deemed to be unable to perform the duties of his office; and

WHEREAS, it is extremely important for individuals who may be married by the Council President of the Borough of Sayreville to be assured that such a marriage has been legally solemnized pursuant to the laws of the State of New Jersey when the Mayor is absent from the Borough of Sayreville for three days or more or is otherwise unable to perform the duties of the office in accordance with N.J.S. 40A: 60-3, in such instances as the Council President performs such ceremony;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Sayreville, in the County of Middlesex, State of New Jersey, that the President of the Borough Council be and hereby is authorized to solemnize marriages between such persons as may lawfully enter into the matrimonial relation whenever the Mayor of the Borough of

Sayreville is absent from the Borough of Sayreville for three days or more or is otherwise unable to perform the duties of the office in accordance with N.J.S. 40A:60-3, whereupon the President of the Council shall perform all duties of the Mayor; and

BE IT FURTHER RESOLVED that the Mayor of the Borough of Sayreville need not make a specific reference to the authorization of the President of the Council to solemnize a marriage in the Borough of Sayreville when the President of the Council is generally authorized to perform all the duties of the Mayor pursuant to N.J.S. 40A: 60-3.

Wished everyone a Happy New Year. Mentioned the DeSarno family and that they need our help and they will pull through. Thanked the emergency services of Sayreville. Welcomed Councilwoman Kilpatrick. He said that Sayreville needs to pursue a sensible development to bring up tax ratables and quality of life for our residents. Projects like the one at Club Bene, the developer is responsible for over one million dollars of improvements. They have to refurbish Old Spye Road to its former cobblestone elegance. They are require to supply at least 20 parking places for the Morgan Fire House and they are required to demolish the Old Club Bene, which has already happened. This is in conjunction with building an age targeted complex. This complex is the first step in revitalizing the Morgan Section of Sayreville. Keep our school taxes down; improve the quality of life of the surrounding areas. This is sensible development which needs to be encouraged. Developers need to be encouraged to come to Sayreville with a reasonable plan. We need a vision of what makes sense not just now but in the future. On business improvement, I would like to create a Business Improvement District, called the Main Street Improvement District. We have some great businesses here in town that nobody

seems to know about. A Business Improvement District provides a mechanism for business and property owners to organize as a single entity and raise funds and activities or expand. In conjunction with my talks with Congressman Pallone and his staff to build a new post office. An Improvement District can help with many amenities to help revitalize Main Street. These projects can be achieved by creating a Main Street Improvement District through Grants that are available to create these districts. And this brings me to a Grant Writer. I would like to request the services of a Grant Writer. Some people believe that a Grant Writer receives a percentage of the Grant and that is not entirely true. Grant Writers are paid by the hour and research and apply for specific projects. I believe we are leaving money on the table in not having one here to work with us. With additional money we can do things in Sayreville. Maybe big things. We have to think outside the box without raising taxes but we need leadership to get it done. We need to move forward on Sayreville Boulevard and the Main Street By-Pass. With the development of the NL Industries property, the approval of a three 200,000 sq ft. warehouses and the Bass Pro Shop coming to town traffic is going to be an ever growing issue for Sayreville. Sayreville has Ten Million Dollars allocated from the State to build these roads. The project is taking way to long, we need to work together to complete this for the safety and convenience of our residents if we all work together.

Our Seniors - A lot of promises are made to seniors and are not fulfilled. I intend to see Jen and talk to her and the seniors. Like the promise of security cameras. He promised they would get there.

Recreation – Years ago plans were developed for a walkway and trail from the Horse Park to the Raritan River and I would like to see the borough engineer look into what we need to do to get it done. Stanly Drwal has had some great ideas on this. I believe with the help from the Middlesex County Open Space Fund we can have a trail we can be proud of.

Public Safety – Years ago we saw Superstorm Sandy devastate parts of Sayreville and recently Sayreville had two extreme house fires. One of the fires claimed the house of a good friend and his family, Paul DeSarno. He is also a good friend of Sayreville's as well. Please keep them in your prayers that they may have a full recovery. With the grace of God and without any loss of life we saw our police and volunteers; EMS, Fire and police go in and save lives with the equipment we provide to them, but with better equipment we can be much safer. These men and women put their lives on the line to save and protect us. The Police, Fire and First Aid Squads use the equipment and training to protect and keep the resident of Sayreville safe. It is our responsibility as council members.

In conclusion – As Council President I want to offer my support and leadership to have the projects we spoke about today to be discussed with the residents and professionals and move forward in having them completed. Sayreville is in a very unique situation. There are many plans in the works and we need to do what is best for the residents of Sayreville. We need to look for ways to get things done and not look for excuses. We are so close to the main hubs of Hoboken and Jersey City and Manhattan that we need to show people why they need to move to Sayreville.
