Councilman Rittenhouse moved the Ordinance be approved on first reading, advertised according to law and a Public Hearing be held on February, 23, 2015. Motion seconded by Councilman Buchanan.

- **CONSENT AGENDA/RESOLUTIONS**

Mayor O'Brien opened the meeting to the public for questions or comments on the consent agenda items.

Those appearing were:

- Michael Pinkiewicz, 32 Becker Drive  
Mr. Pinkiewicz handed out information he would like to discuss. Clerk Farbaniec distributed to the Council.  
Questioned Resolution #2015-42 and asked the council to clarify that the agreement was with the Tinton Falls location of Associated Humane Society. Mayor confirmed that it was.  
He questioned why we selected them and did not keep Woodbridge.

Mayor said that Woodbridge was servicing Sayreville on a temporary basis and that they do not have the excess capacity to keep on permanently.

Mr. Pinkiewicz asked when they submitted their RFP as it was noted on Dec. 15<sup>th</sup> that there were none received.

Mayor said that the Business Admin. was not in attendance and that he would be the one to respond.

Municipal Clerk Farbaniec stated that the authorization to negotiate a contract was given after it was noted that there were no RFP's received on the designated date.

He questioned why we selected Associated Humane Society.

Mayor responded that it had a lot to do with them having capacity and price. That they would provide services at the lowest reasonable costs.

Mr. Pinkiewicz stated that in his handout was a report and for 2014 for the Associated Humane Society and that he could not find intake, adoption and euthanasia rates for their animals. He said that he was not sure if this choice would be any better than Helmetta. He then commented on their filing of a lawsuit against the City of Newark in 2011 regarding the possession of "Patrick the Pit Bull" and their losing fundraising potential. He said that he is concerned that there are not other options presented and this is the only choice. He said that they do not advocate for their pets and expressed concerns regarding the traffic to reach Tinton Falls.

Councilman McGill said that he did visit Tinton Falls facility and felt comfortable with what they saw and was told. Woodbridge does not want to take us any longer, he was not comfortable taking animals up to the Newark facility. He understood the amount of time it may take for the residents to get there but felt this facility was much better than Helmetta, until more shelters became available to contract with.

Mr. Pinkiewicz stated that there were rumors that Woodbridge would not contract with us because we do not support TNR. Further response by Councilman McGill.

Councilwoman Kilpatrick stated that it was her understanding that Animal Control would be located in the town locally during regular business hours. She also spoke about the scramble for many towns to locate a shelter after the issues with Helmetta.

- Rachel Collier, 42 Garfield Place  
Commented on her concerns about the facility and concerned that we will be distancing local control to other neighborhoods. She also commented on a pleasant experience she had dealing with Woodbridge. She also referred to certain comments that were made by the Sayreville Police Dept. She felt it should be up to the residents to vote if we want animal control back in Sayreville.  
Mayor informed her that she could have a non-binding referendum placed on the next ballot but he follows that mandate to supply services at the lowest reasonable cost available.

Mayor said that it is a lot more than just housing the animals. You have to have proper facility, personnel, vehicles, etc. which is a large expense. When Helmetta built their facility it was meant to be a revenue generator to offset the costs and keep taxes down.

Ms. Collier asked how many towns Tinton Falls house.

Mayor suggested she put together a committee with an odd number of people who are residents of **Sayreville** of like mindedness-form it and you can do the inspections on behalf of the Borough of Sayreville and work with the Board of Health and Police Dept. Discussion followed.

Council President Dave McGill made a motion to close the public portion and approve the Consent Agenda Resolutions on Roll Call Vote. Motion was seconded by Councilman Buchanan.

  - Further stated that on Jan. 27<sup>th</sup> he wrote a letter to Mr. Frankel regarding the documents he did not receive and to this date no response, except for a letter from him previous to that date regarding the change in coverage.
