ORDINANCE #09-26
AN ORDINANCE SUPPLEMENTING AND AMENDING ORDINANCE #03-24
FIXING THE SALARIES OF CERTAIN BOROUGH OFFICIALS, OFFICERS
AND EMPLOYEES FOR THE YEARS 2023-2027

WHEREAS, the position of Management Specialist was created by Ordinance in 2022, however, through ministerial error the position was not included in the Borough’s salary ordinance at that time; and

WHEREAS, the Borough is correcting this error by amending its salary ordinance to provide for the compensation for the position of Management Specialist retroactively to 2023.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Borough Council of the Borough of Sayreville as follows:

Section 1. The following annual salaries be and the same are here established for the following Borough Officials, officers and employees and made part of Appendix 1 of Ordinance # 03-24 and made part hereof.
