NOW, THEREFORE, BE IT RESOLVED, by the Sayreville Economic and Redevelopment Agency that the Chairperson and/or the Executive Director are hereby authorized to sign documentation from SERA evidencing the aforementioned Sign Lease Agreement and such other documentation as may be required by SSA's title company in order to clear and/or perfect title with respect to the Subject Billboard, subject to the prior review and approval of such documentation by the Agency Attorney.

IT IS FURTHER RESOLVED that the Chairperson and Agency Professionals are hereby authorized and directed to take any action and to execute any documents as may be necessary to effectuate this Resolution.
