**AN ORDINANCE TO SUPPLEMENT AND AMEND**  
**CHAPTER VI, SECTION 6-4.1 “ALCOHOLIC BEVERAGE**  
**CONTROL FEES” AND CHAPTER II, SECTION 2-64**  
**ADMINISTRATION-FEES OF THE REVISED GENERAL**  
**ORDINANCES OF THE BOROUGH OF SAYREVILLE**

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Sayreville, in the County of Middlesex, that **Chapter II Administration, Section 2-64.8 Fees-Liquor Licenses** of the Revised General Ordinances of the Borough of Sayreville, shall be supplemented and amended as follows:
