Dear Board Members:

The applicant proposes to renovate and expand the existing building to serve as an office for their Heating & Plumbing business. As the site is situated along a State Highway, the trip generation figures below were obtained from the NJDOT Highway Access Permit database.

For Land Use Code Y52, General Office < 200,000 S.F. the rates are as follows:

AM Peak Hour

1.47 * (X/1000) where X represents the total square footage proposed X = 4140 / 1000 = 4.14 AM Peak Hour Total: 6 trips

PM Peak Hour

1.42 * (X/1000)

PM Peak Hour Total: 6 trips

Weekday Daily Trips

EXP (0.97 * Ln (X/1000) + 2.5)= EXP (3.88)

Weekday Daily Trips Total: 48 trips

Weekend Peak Hour

0.53 * (X/1000)

Weekend Peak Hour Total: 2 trips

Weekend Daily Trips

2.21 * (X/1000)

Weekend Daily Trips Total: 9 trips

Based on the above, the number of trips does not constitute a major traffic generator. Since the only access is from the State Highway, the jurisdiction of same is with the NJDOT. On April 10, 2024, the applicant received a Letter of No Interest from NJDOT. A copy of same is attached.
